The Great Bay Resource Protection Partnership (GBRPP) is offering grants to assist with land transaction costs for the permanent land protection projects in the Piscataqua region coastal watershed area of New Hampshire and Maine.

The Great Bay Resource Protection Partnership is a collaboration of conservation organizations in the coastal region that promotes landscape-scale land conservation and stewardship. Funding for the Land Protection Transaction Grant program is provided by the New Hampshire Charitable Foundation. II. Grant Guidelines and Program Options

- 1. Eligibility
- **Applicant.** Qualified nonprofit tax-exempt 501(c)(3) conservation organizations or units of government may apply for a grant.
- **Project**. Permanent land protection projects, including the donation and/or acquisition of full fee and conservation easements.
- **Geographic Eligibility.** The property must be located in the Great Bay Watershed of New Hampshire (see attached map and municipality list).

• Property Eligibility

See Section B Application Instructions and the Appendix Instructions: NH Coastal Viewer to Determine Project Eligibility for details on determining eligibility.

The property must coincide with at least one of the three priority conservation resource areas listed below. The application will be considered more competitive if the property includes more than one priority conservation resource area.

- A. Conservation Focus Area, 2021 NH Coastal Watershed Conservation Plan
- B. Agricultural Resources, 2021 NH Coastal Watershed Conservation Plan
- C. Tidal Water Shoreline, See National Wetlands Inventory

While most projects that meet one or more of the eligibility criteria are eligible for funding, certain situations are generally not a good fit with the intent of the grant program. For example, easement agreements associated with permit requirements, projects involved in legal disputes, parcels with substantial contamination, or easements with dam maintenance provisions are examples of projects that are not considered a good fit for this program.

2. Grant Award Limits

- An organization may be awarded up to \$45,000, including the combined awards from Grant Program 1 Appraisal and Grant Program 2 Completed Project.
- The maximum grant award for Grant Program 1 is \$4,000 per property.
- The maximum grant award for Grant Program 2 is \$25,000 per property.
- A separate application must be submitted for each conservation property.

See guidelines below for Grant Programs 1 & 2.

3. Grant Program 1 Prospective Project Appraisals, up to \$4,000 per project

Grant funds awarded in Grant Program 1 are for property appraisals. The purpose is to provide assistance with appraisal cost for projects where the applicant needs an appraisal to begin negotiations with the landowner or assess project viability. Completion or closing of the project is not required.

- Maximum grant amount: \$4,000 per project or 50% of the appraisal cost, whichever is less.
- A minimum of one-to-one (1:1) match requirement for grant funds. That is, an applicant must offer for appraisal costs at least \$1 in match funds for every \$1 of grant funds.
- Match funds may be from nonfederal or federal funding sources.
- Appraisal Expense Date: See Table 1, page 4.

4. Grant Program 2 Completed Project Transaction Costs, up to \$25,000 per project

Grant funds awarded in Grant Program 2 may be used to reimburse transaction expenses of permanent land protection projects.

- Maximum grant amount: \$25,000 per project.
- Match funds are <u>optional</u> for Grant Program 2 projects. However, demonstrating contributions of other project funds and services will enhance the application, and demonstrate project readiness.
- Match funds may be from nonfederal or federal funding sources.
- Closing Date for projects: See Table 1, page 4
- Preference will be given to projects for which there is a contractual agreement in place such as a signed purchase and sale agreement or option agreement.

Grant Program 2 Eligible Grant Transaction Expenses:

- Expenses include Appraisal, Baseline Documentation Report, Environmental Hazard Assessment (Level I), Land Survey, Legal Fees, Recording Fees, Title Expenses, Professional Fees (see below), and Staff costs (see below)
 - Professional fees may include Wetland Studies, Ecological Assessments, Resource Management Assessments and Plans, and other related services.
 - Staff costs up to 15% of the total LPTGP Grant request. Staff costs must be directly related to the project negotiation and project management activities. Noneligible staff-related costs include media and fund-raising activities, separate organization indirect / overhead costs, and other such activities.
 - Due diligence activities such as Environmental Hazard Assessments and Baseline Documentation Reports completed by the applicant / NGO staff are eligible Grant expenses.
- Expenses are reimbursable at the completion of the project.
- Grant Fund Expense dates: See Table 1, page 4

Grant Program 2 Match Transaction Expenses:

- Match funds may include all transaction costs identified as eligible Grant Expenses, as well as other transaction costs including Stewardship Fund and Endowment, Staff time (not included as Grant expense).
- Match Fund Expense dates: See Table 1, page 4.

III. Grant Submission and Award Process

IV. Application Form

The Applicant must complete an application form for each project and provide all requested maps.

V. Due Date & Submission Requirements

- Applications must be <u>electronically submitted</u> by *October 5, 2023*. See Section VI Grant Submission for instructions. Applications should not be mailed or emailed directly to the GBRPP.
- A complete Application includes the Application Form, Maps and Property Shape File(s). Only complete applications will be considered.

VI. Limits to Funding

- An organization may be awarded up to \$45,000, including the combined awards from Grant Program 1 Appraisal and Grant Program 2 Completed Project applications.
- The maximum grant award for Grant Program 1 is \$4,000 per property.
- The maximum grant award for Grant Program 2 is \$25,000 per property.

VII. Award Process

- Applicants will be notified by email of the receipt of their application and the award decision.
- Award decisions will be competitive in nature. Projects that meet more than one eligibility criteria, protect larger parcels of land, and/or provide higher ratios of match will rank most competitively.
- Award decisions will be determined by a panel of Partnership conservation agency representatives.

IX. Forms and Process

- All Grantees will be expected to submit one invoice per project, using the invoice template.
- Reimbursement of approved expenses will be issued to Grantees as a one-time lump sum.
- Invoices must include documentation (see below) of reimbursable Grant costs and Matching costs. Invoices will not be paid without this documentation.
- Grantees must retain on file receipts, timesheets, etc. that support reimbursable expenses in case of an audit, or if questioned.
- Invoice Submittal Process: See *GBRPP LPTGP Invoice Electronic Instructions* document on the GBRPP Website Grants Program page.

X. Grant Program 1 Additional Invoicing Requirements

- Provide documentation of appraisal cost (appraisal invoice, dated) and evidence of its completion (copy of appraisal cover letter, with signature). Submit invoice and documentation as stated in the Grant Agreement. See appraisal grant transaction and closing dates in Table 1, page 4.
- Match funds do need to be documented.

XI. Grant Program 2 Additional Invoicing Requirements

- Eligible transaction costs must have been expended, and all required invoicing and documentation by the closing date in Table 1, page 4.
- Grant Funds: Documentation of expenditures to be reimbursed.
 Documentation shall include a paid invoice for services. Staff costs may be verified in a letter stating the staff costs (professional service time), service performed, and range of dates activity occurred.
- Copies of the property closing settlement sheet and recorded deed and/or conservation easement.
- Other requirements as may be stated in the Grant Agreement.
- Match funds claimed do not need to be documented. Match funds should be shown in the invoice budget table.

V. Match Guidance

- **1. Grant Program 1.** A <u>minimum</u> of one-to-one (1:1) match requirement for grant funds. The maximum grant award is \$4,000 per project or 50% of the appraisal cost, whichever is less. Funds may be federal or non-federal in origin. Match funds must be documented.
- **2. Grant Program 2.** Match funds <u>are optional</u> for Grant Program 2 projects. Demonstrating contributions of other project funds and services will enhance the application and demonstrate project readiness.
 - Funds may be federal or non-federal in origin. Match contributions may be "cash" or "in-kind services" directly related to the project.
 - Match funds may include all transaction costs identified as eligible Grant Expenses, as well as other transaction costs including Stewardship Fund and Endowment, Staff time (not included as Grant expense), and other transaction-related expenses.

In-kind services can be paid staff time or volunteer time, which is directly related to implementation of the project. Volunteer hours can be valued at the current rate for New Hampshire posted at http://www.independentsector.org/resource/the-value-of-volunteer-time/ Higher in-kind rates can be claimed if a person volunteered services in their professional capacity. In this case, the volunteer rate is the person's "billable" rate for the service. The Grantee will be required to provide verification of employee and volunteer time that is claimed as match.

VI. Grant Submission

Applications must be <u>electronically submitted</u>, no later than due date (see Section III.2). Land Protection Transaction Grant Program Applications are emailed to a file sharing server (Box). Do not mail or email the application directly to the Great Bay Coordinator. See instructions below.

A complete Application includes: Application Form, Maps and Property Shape Files.

1. File Organization & File Naming

It is preferred that the complete Application including the Application Form and Maps be submitted as a single PDF file. The Property Shape Files should be sent as a separate file.

Application Signature

The Application may be signed digitally. Digital signatures include a scanned signed document, a scanned signature, or a digital signature created using a third-party application (e.g. Docusign).

 - Plain Text. If possible, please send the email as "Plain Text". This will avoid the upload of logos/social media icons in the footers of the email. In "Outlook" mail you can change to plain text on the "Format Text" tab an select "As Plain Text" in the upper left. In "OIS" mail, under the "Format" Tab use "Make Plain Text".

B. Receipt Verification

- After submittal, the applicant will receive an email receipt from: 'noreply@box.com notification'.
- The name of the folder will appear: 'GBApplication_LPTGP folder' in the receipt. Note the receipt may take a few minutes to appear in your email, depending on file size. If you don't see the receipt in your inbox, check your spam/junk mailbox. In addition, a confirmation email will be sent to you from the GBRPP (bluesky24@comcast.net) confirming receipt of the application.



III. Eligibility Criteria

1. Geographic Eligibility 2023. The Property must be located within the NH Great Bay Watershed. Several of the 42 municipalities are partially in the watershed boundary.

Municipalities Barrington, Brentwood, Brookfield, Candia, Chester, Danville, Deerfield, Dover, Durham, East Kingston, Epping, Exeter, Farmington, Fremont, Greenland, Hampton, Hampton Falls, Kensington, Kingston, Lee, Madbury, Middleton, Milton, New Castle, New Durham, Newfields, Newington, Newmarket, North Hampton, Northwood, Nottingham, Portsmouth, Raymond, Rochester, Rollinsford, Rye, Sandown, Seabrook, Somersworth, Strafford, Stratham, Wakefield.



2. Property Eligibility

The property (or properties) to be protected must coincide with at least one of three (A through C) priority conservation resource areas listed below. In the application document, check all that apply and complete the relevant information fields. The application will be considered more competitive if the property(s) include more than one conservation priority. See the Appendix *Instructions for using the New Hampshire Coastal Viewer* to screen your project's eligibility (includes criteria A, B, and C). Eligibility Criteria A and B website links provided below for reference.

C. Tidal Water Shoreline

- Water resource benefits, and shoreline, river and/or wetland buffers.
- Other conservation features and benefits.
- Connectivity with other permanently protected conservation lands.
- Community benefits and public access.

B. Applicant, Partners, Stewardship (250 words or less)

Describe the following:

- Applicant capacity.
- Project partners.
- Strategy for long-term stewardship.
- C. Project completion date (after property closing).

Appendix Instructions: NH Coastal Viewer to Determine Project Eligibility

The New Hampshire Coastal Viewer is an online mapping tool with a geographic focus on New Hampshire's coastal watershed communities. The Coastal Viewer can be used to screen your project's eligibility for this grant program.

2023 LTPGP Eligibility: Properties must be within the NH Great Bay Watershed.

This area can be found using the Land Protection Grant Layer Theme on the NH Coastal Viewer to determine whether your project is within the geographic eligibility for 2023 funding.

The Coastal Viewer will be updated by 4/21/2023 to include the NH Great Bay Watershed boundary.

The following instructions are based on the March 2022 version of the Coastal Viewer. Users should refer to guidance on the Coastal Viewer for updates that may be introduced in subsequent releases of the website.

A landing page on the Coastal Viewer was developed specifically to meet the screening needs of this program at <a href="http://nhcoastalviewer-lptg.unh.edu/">http://nhcoastalviewer-lptg.unh.edu/</a>. This page only displays the data layers that are relevant to the grant program's eligibility; to view all the Coastal Viewer data layers use the dropdown on the left side of the screen under the "Layers" heading and select "All Layers".

There are a variety of getting started and training resources for the Coastal Viewer at <a href="http://www.nhcoastalviewer.org/">http://www.nhcoastalviewer.org/</a>. If you are new to the Coastal Viewer please consider watching the 9-minute <a href="Get Started">Get Started</a> video, which will help you to understand how to use the application. Basic navigation of the viewer and its tools are described.

Data layers in the Coastal Viewer are organized by folders, some of which you need to drill down through (clicking the check box along the way to activate them) to get to the data layer that you want to view. Folders are differentiated in the list below by **bold headings**, whereas data layers are shown below. When you turn on a **folder** you are not turning on a viewable data layer, but rather enabling the viewing of a data layer within the folder; the data layer needs to be turned on to view it (and all folders it is within also need to be activated—this is a common pitfall and frustration for these types of applications).

When you open the Coastal Viewer using this <u>link</u> you will see the following structure of **folders** and data layers available for viewing in the "Layers" list on the left side of the screen:





<u>Selecting a Basemap – The Coastal Viewer by default uses the "Bing Roads" basemap. You can change the default basemap to "Bing Aerial" by following the steps below:</u>


1. Locate the "Bing Roads" icon in the lower left-hand corner of the Coastal Viewer map extent. See screen capture below for location represented in the red box. \*\*Note: If you hover your cursor over the icon, a pop-up text will say "Select a basmap"




2. Click on the "Bing Roads" icon to expand your basemap options.



The screen capture below shows you the expanded list of basemap options. Note that the activated basemap has a blue box around it.



4. Click on the "Bing Aerial" icon to switch the default basemap to the "Bing Aerial" option. See screen capture below.



The basemap icon now should say "Bing Aerial" and there should be aerial imagery within the Coastal Viewer map extent (see screen capture below). You have now successfully switched to the "Bing Aerial" basemap.
